

UP Tower 55 has tracks connecting North & South and East & West at this junction, controlling UP, BNSF, FW&W, Amtrak and Trinity Railway Express. It is considered one of the nation's busiest diamonds.



On the left is the track diagram of Tower 55's double track crossing and rail connections of all four quadrants. On the right is a Union Pacific train going through the interlocking with Ft. Worth in the background. Tower 55 traffic is now controlled at Davidson Yard, where the track diagram photo was taken, while the actual tower is currently used by signal maintainers.

## **AMTRAK/FEC CORRIDOR IN FLORIDA - FEDERAL STIMULUS PROJECT**

Florida's local governments, regional planning councils, FDOT, Rail America (owners of the FEC railway) and Amtrak have been working together on a \$268 Million ARRA application/proposal to reintroduce passenger service, via Amtrak, on 326 miles of FEC railway between Jacksonville and Miami. The project will create 2,100 jobs through its three-year construction timeframe according to FDOT estimates.

### ***Project Timeframe***

- First ARRA application submitted October 2, 2009  
(*High-Speed Intercity Passenger Rail (HSIPR) program, Track 2 funding*)
- Second ARRA application submittal - expected mid-to-late 2010
- Other potential ARRA funding sources currently under evaluation
- Expected project construction: 3 years

### ***Project Scope and Operations***

- \$268 Million dollar passenger rail project affecting 326 miles of Florida's east coast, between Jacksonville and Miami
- The new Amtrak/FEC corridor project will provide rail transit service to 11 Florida counties and 8.3 million Floridians. This population is projected to grow to over 10 million by 2020
- Counties served: Duval, St Johns, Flagler, Volusia, Brevard, Indian

□ 8 new stations to be constructed:

St. Augustine, Melbourne,  
Daytona, Vero Beach,  
Titusville, Fort Pierce,  
Cocoa, Stuart.

- Rail interconnection constructed between CSX and FEC in the West Pam Beach area (will accommodate Tri-Rail extension north into northern Palm Beach County)
- 2 trains running northbound and southbound to start (could grow to 4-6 trains daily)
- Trip between Jacksonville and Miami should take roughly 6 hours
- Early ridership forecasts indicate more than 175,000 annual riders for this service

### ***Statewide Project Support***

- More than 130 resolutions and letters of support adopted by public and private organizations around the state (see attached). These include city and county commissions, MPO boards, regional planning councils, chambers of commerce, tourist development councils, merchants' associations, state-wide organizations, and others.
- Florida's only ARRA transit application in partnership with a national entity (Amtrak)

### ***Economic Development Impacts***

- The project will implement redevelopment plans, increase "stay-cations" (vacations within Florida for Floridians), increase local spending capture, and provide immediate construction jobs along the entire east coast of Florida
- Near-term job creation and economic stimulus for Florida's workforce, businesses, and national and international tourism
- Project is expected to create 2,100 direct and indirect jobs through service initiation (2013) and 6,300 jobs through 2025

### ***Florida's Greener Future***

- The Amtrak project is part of Florida's statewide transit network which will improve mobility, reduce carbon emissions, and reduce dependence on foreign oil
- Immediate traffic reliever for I-95
- Immediate reduction in GHG emissions and VMT in Florida

### ***Politics of the Project***

- This will be the first-time passengers have ridden on FEC rails since 1968
- This is a high profile, "green" project with loads of citizen support
- This entire rail project gets built for about \$750,000 per mile as opposed to most passenger rail projects which come in at the \$5 - 10 Million per mile range ~ this project is a bargain as far as rail goes
- Project "ribbon-cutting" opportunities present themselves at each of the new stations
- Amtrak's inaugural passenger train run on the FEC will become a significant media event
- Project will be completed within three years – immediate jobs and visibility

- Website Committee: There was much discussion surrounding keeping, or not, the rlhssec.org website after the October renewal is required. Cliff Vander Yacht researched having our website be connected with the National website. Indications are that the Chapter should keep and have its own unique website. The Chapter will vote on keeping the site at the August meeting.

### Old Business:

- There is no update on the ACL 1504 project. More meetings of the interested parties are planned.
- Ed Mueller reported on his and John Leynes' project regarding a new DVD on railroad music. This topic is still pending and will be discussed further as it is developed.
- Ed Mueller recommends a meeting in conjunction with the Palatka Railway Preservation Society group and will research having the Palatka group give a presentation for our August meeting.

### New Business:

- Larry Shugart is hosting a reception February 26<sup>th</sup>, 2011, and has requested volunteers to help host his event.
- Upcoming Programs:
  - August 12: Palatka Railway Preservation Society.
  - September 9: Paul Newton on a private luxury railcar excursion.
  - October 14: Fred Brechler, the 20<sup>th</sup> Century Limited.

The meeting was adjourned at 7:45 PM by Chairman Jim Smith.
