**“Trainspotters, you’re welcome back to Bowden”**

Dear Call Box: My 86-year-old husband, who is a Navy veteran, likes to watch trains. For years, we have parked our car near Bowden Yard to watch them go by. On Nov. 17, we were asked to leave. We contribute to the Jacksonville economy when we visit by staying in your hotels and eating at your restaurants. We truly regret that we are not welcome anymore. From: A.G., Daytona Beach Shores.

Dear A.G.: You and your husband are welcome to return to the Florida East Coast Railroad yard at any time, said Bob Ledoux, the railroad's vice president. On weekdays, there is someone to direct visitors to the parking lot area where they can safely indulge their trainspotting hobby and snap pictures or video. What happened is that you came to the yard on a Saturday when the building is closed, and a security guard was on duty. The guards have been told to tell future weekend visitors that it's OK to stay, as long as they remain in the parking area, Ledoux said. The yard is at 7150 Philips Highway between Baymeadows and Bowden roads.

By the way, one of the most popular places to watch trains is Folkston, Ga., about 42 miles north of Jacksonville, said Gary Sease, a spokesman for CSX Transportation. In 2001, the town got a \$30,000 state grant to build a platform that boasts chairs, ceiling fans and a scanner to listen to radio traffic between trains. It attracts fans from along the East Coast and visitors from as far as England and France. Picnic tables, a grill and a restroom facility are adjacent to the platform, according to its website.

Nicknamed the “Folkston Funnel,” the double track is one of the busiest spots on the CSX line and serves as the main artery for train traffic into and out of Florida. The number of trains averages 35 to 40 but sometimes goes up to 60. In April, one day is designated as Rail Watch, a time for aficionados to compare notes and photos. In 2013, it's set for Saturday, April 6th.

Tavares, FL - Get on board for a photo train that is friendly to railfans and photographers!

The Tavares, Eustis & Gulf Railroad will operate a spring photo special on March 9, 2013. The “8:10 to Lake Jem” will depart Tavares at 8:10 AM for a 3 hour round trip.

The trip will be pulled by No. 2, a 1907 2-6-0 wood-burning locomotive built by Baldwin. Consist will include 3 vintage coaches, built in 1915, and one Cotton Belt caboose, built in 1918. The train will make four photo run-by stops.

Fares for this excursion are \$40 for adults and \$25 for kids ages 4 to 12. Cupola seats are \$45, regardless of age. Prices includes the train ride, photography opportunities, coffee, breakfast rolls, soft drinks, water, and snacks.
